- **Final Decision (Acceptance/Rejection):** July 30, 2026

All interested authors are informed to follow the **author guidelines**: formatting, style, guidelines, and conventions as per the APA manual (2020) strictly. Manuscripts with more than **20% plagiarism and AI-generated content, or those that do not fully comply with the submission guidelines, will be rejected without review**. Late submissions will not be accepted.

1. Author Guidelines:

Manuscripts must meet the following criteria:

Format: Submit as a single **MS Word** file including all text, charts, tables, figures, and graphics.

Length: 4,000–7,000 words (including title and references).

Text Specifications:

- **English:** Times New Roman, 12-point., single-spaced, A4 size, left-aligned.
- **Nepali:** Unicode, 12-point, single-spaced, A4 size, left-aligned.

2. Required Components for Anonymized Manuscript:

- **Title:** Maximum 15 words, bold, 12-point.
- **Abstract:** 150–300 words, italicized, justified, single-spaced.
- **Keywords:** Maximum 5 words or phrases.
- **Headings:** Introduction, literature review, objectives/RQs, methodology, results/findings, discussion, conclusion.
- **References:** Minimum 15 reliable sources.
- **Appendices:** If applicable.

3. Required Components for Author(s) Details:

- *Manuscript's Title*
- *Author(s)' name, designation, affiliation, email, ORCID,*

- *About Author(s) (No more 60 words)*
- *Declaration*
- *Acknowledgements*
- *Funding (If any)*

Note: *Author(s) must submit the author details and anonymized manuscripts Word files separately.*

Manuscripts must be original, unpublished, and not under consideration elsewhere. Authors are responsible for upholding ethical standards throughout the publication process. Upon acceptance, authors must agree to the copyright terms of SHSS.
